**Course Objective:** The objective of the SBSI course is to engage the youth for achieving the vision of a **CLEAN, GREEN and HYGIENIC INDIA**. This course aims to develop and enhance the leadership and management skills of the youth by engaging them for Swachh Bharat Mission.

**SBSI Course Assessment:** The total marks allotted for this 2 credit course is 50 marks. The assessment will include an In-Semester-Assessment(ISA) component with 40% weightage(20 marks) and the Semester-End-Assessment(SEA) component of 60% weightage(30 marks)

1. The ISA assessment of total 20 marks shall be carried out by SBSI Mentors appointed by the Head of Department. The assessment will be broadly based on the following parameters –
  - i. Submission of SBSI Proposal in specified format and Submission of Final Report as per the output parameters listed on the sbsi portal (10 marks)
  - ii. Team Work, Implementation of the proposal plan, Evidences captured of the activities carried out – before / after photos, video clippings, Youtube videos, questionnaires (5 marks) and
  - iii. Any other parameters as decided by the SBSI Mentors (5 marks)
2. The SEA assessment of total 30 marks shall be carried out by the SBSI Evaluation Committee appointed by the Vice Chancellor. The assessment will be broadly based on the following parameters –
  - i. Submission of final report (10 marks)
  - ii. Presentation on the work carried out during the internship period(10 marks)
  - iii. Feedback in any form(video/feedback form) obtained from the head of the Village / Sarpanch / the Villagers (10 marks)

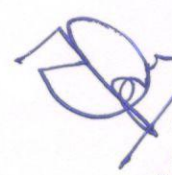

## Two credit Swachh Bharat Summer Internship (SBSI) Course

### List of Suggested Module-wise Activities for submitting the SBSI Internship Proposal

#### Module A) Data Collection and Analysis


1. Conduct Village or School-level Rallies to generate awareness about sanitation and UBA Village Survey – minimum one village per Team
2. Conduct Door-to-door meetings to drive behavior change with respect to sanitation behaviors and UBA Household Survey – minimum 10 houses per student

#### Module B) Awareness Campaigns around better Sanitation Practices

1. Perform Nukkad Natak or street plays around swachhata
2. Organise Swachhata Melas, song and dance performances
3. Make wall paintings in public places (more specially panchayat offices) on the theme of swachhata
4. Participate in Nigrani committees to stop open defecation in villages
5. Organise Swachhata-related movie screenings in public places. (Swachh Bharat movies may be found on the YouTube channel [tinyurl.com/sbmgramin](http://tinyurl.com/sbmgramin) and community screenings of these films may be organized in public places in the villages to help spread the message of Swachhata)
6. All Resource Material of Swachh Bharat Mission may be freely downloaded from the links [tinyurl.com/sbmiec](http://tinyurl.com/sbmiec) and [tinyurl.com/sbmiec2](http://tinyurl.com/sbmiec2).
7. Any other activities undertaken to help spread these messages to the rural masses would count under this module

#### Module C) Solid Waste Management (SWM) related activities

1. Organize Waste collection drives in households and common or shared spaces
2. Volunteer for segregation of solid waste into non-biodegradable and biodegradable waste
3. Mobilize community and Panchayat to build compost pits, where organic matter decomposes to form manure.
4. Help Panchayats draw up plans for installation of biogas plants
5. Organize cleaning of streets, drains and back alleys through awareness drives

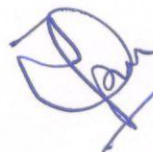
